ARTICLES OF INCORPORATION OF C. HOLLAND TRUCKING, INC.

SECONDATION OF FILE

I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be: C. HOLLAND TRUCKING, INC..

ARTICLE II - PRINCIPAL PLACE OF BUSINESS
