ARTICLE XII, REGISTERED AGENT AND REGISTERED OFFICE.

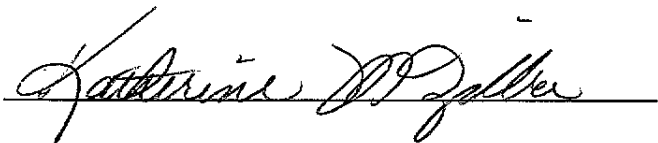
