

## Articles of Incorporation of Humanitico, Inc.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

### Article 1.

#### Name and Address

The name of the Corporation is Humanitico, Inc. The principal office and the mailing address of the Corporation is 1594 Northgate Drive, Naples, Florida 34105.

### Article 2.

#### Duration

The duration of the Corporation is perpetual.

### Article 3.

#### Purpose

The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.

### Article 4.

#### Shares

The aggregate number of shares which the Corporation is authorized to issue is Two Thousand Five Hundred (2,500) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

### Article 5.

#### Initial Registered Office and Agent

The street address of the initial Registered Office of the Corporation is Morrison & Conroy, P.A., 3838 Tamiami Trail North, Suite 402, Naples, Florida, and the name of its initial Registered Agent at that address is Kristin M. Conroy.

Article 6.  
Initial Board of Directors

The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased or decreased from time to time in accordance with the By-Laws but shall never be less than one. The name and address of the initial Director of the Corporation is as follows:

Indemnification


