ARTICLES OF INCORPORATION OF TCP TRANSPORT LOGISTICS, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I


