**ARTICLES OF INCORPORATION
OF
PREFERRED CLIENT SERVICES, INC.**

THIS IS TO CERTIFY that we, the undersigned, for the purpose of forming a corporation under the provisions of Florida Statutes, and any amendatory thereof and supplementary thereto, do hereby make, subscribe, acknowledge, and file these Articles of Incorporation, as we do certify that:

1. The name of the corporation is: PREFERRED CLIENT SERVICES, INC.
2. The address of the principal office of the corporation shall be 5136 51st Way, West Palm Beach, FL 33409
3. The major purpose of the corporation will be to engage in any one or more legal businesses and to exercise any and all the powers authorized and permitted by the said Statutes to corporations formed thereunder.
4. The amount of capital stock authorized shall be One Hundred (100) shares of common stock at a par value of one dollar (\$1.00) per share.

The corporation shall commence business with not less than One Hundred (\$100) dollars in cash.

The corporation shall have perpetual existence.

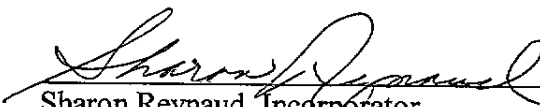

The private property of the stockholders, officers and directors shall not be subject to the payment of the obligations of the corporation to any extent.

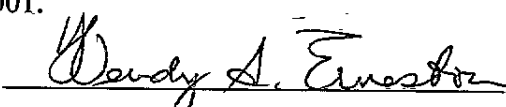

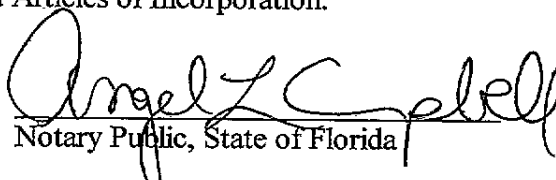
