Duchesneau, M.D. resigned his Directorship, all offices and as Registered Agent of Tahiti Joe's of Tampa Bay, Inc. and of Keen Concepts Inc.

Also, M. Sean Caldwell has assumed a seat on the Board of Directors and has become President of Tahiti Joe's of Tampa Bay, Inc.

Also, David Laxer has assumed a seat on the Board of Directors and has become Secretary and Registered Agent of Tahiti Joe's of Tampa Bay, Inc.
