THE UNDERSIGNED Subscriber to these Articles of Incorporation, as a natural person, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is: KIMBERLEY SCOTT, INC.

ARTICLE II

BEGINNING OF CORPORATE EXISTENCE

The existence of this corporation shall commence on the 31st day of December, 2000; provided that if such day be unauthorized under law, then on the earliest day allowable pursuant to Florida law the corporate existence shall commence.

ARTICLE III

NATURE OF BUSINESS

This corporation is organized for any lawful purpose under the laws of the State of Florida and United States of America including but not limited to consulting business.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue one thousand (1000) shares of common stock, having a nominal or par value of five (\$5.00) dollars per share.

ARTICLE V

INITIAL CAPITAL

The corporation shall indemnify all officers and directors, and former officers and directors, to the full extent permitted by law as the law now exists or may be amended hereafter.




