The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation or profit under Chapter 607 of the Florida Statues.

ARTICLE 1 - NAME

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE 7 CORPORATE CAPITALIZATION

- 7.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is SEVEN THOUSAND FIVE HUNDRED (7,500) shares the common stock, each share having the par value of ONE DOLLAR (\$ 1.00)
- 7.2 No holder of shares of stock of any class shall have any preemptive right to subscribe to or purchase any additional shares of any class, or any bonds or convertible securities of any nature; provided, however, that the Board of Director(s) may, in authorizing the issuance of shares of stock of any class confer any preemptive right that the Board of Director(s) may deem advisable in connection with such issuance.

All of the shares of stock of this Corporation may be subject to a Shareholder's Restrictive Agreement containing numerous restrictions on the rights of the shareholders of the Corporation and transferability of the shares of stock of the Corporation.
