

ARTICLE I CORPORATE NAME



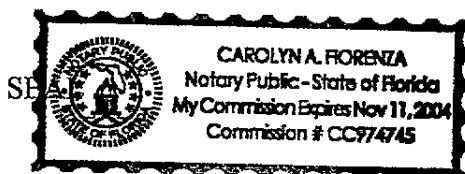
