**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is Power Finance Corp. Its principal office address and business mailing address is 1525 NW 167 Street, Suite 145, Miami, Florida 33169.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**


**ARTICLE VI - INITIAL BOARD OF DIRECTORS**




