ARTICLES OF INCORPORATION

OF

Jazzico Inc.

ARTICLE I - NAME

The name of this corporation is Jazzico Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing upon the filing of the Articles of Incorporation with the Secretary of the State of Florida.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in transacting any and all lawful business for which corporations may be incorporated under chapter 607 of the Florida Statutes.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock at a par value of \$1.00 per share

ARTICLE V - PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be 5102 Belmere Parkway #2501 Tampa, Florida 33624.

ARTICLE VI - REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 5102 Belmere Parkway #2501 Tampa, Florida 33624. The name of the initial registered agent of this Corporation is Jonathan Robert Medici.



ARTICLE VII - INITIAL BOARD OF DIRECTORS AND OFFICERS

The initial directors and officers of this corporation shall be as follows:

President and Director:

Vice President / Secretary/ Treasurer & Director: Jonathan Robert Medici

ARTICLE VIII - RIGHTS OF INITIAL DIRECTORS

The corporation shall have at least one (1) but no more than five (5) directors. Each of the initial Directors shall have the right to be a Director of the Corporation as long as that respective Director becomes a Shareholder of the Corporation. By acquiring stock in this Corporation, each shareholder agrees to abide by this right and to elect each of the initial Directors named in these Articles of Incorporation to the office of Director as long as that Director is a Shareholder of the Corporation. Future Directors need not be shareholders. This Article nay not be amended in any way without the written consent of each of the initial Directors who is a Shareholder of the Corporation at the time of the amendment until after the adoption of the By-laws at the initial meeting of shareholders and directors following which the procedures set forth herein of in the by-laws, as may by amended from time to time, shall control.

ARTICLE IX - INCORPORATORS AND SUBSCRIBERS

ARTICLE X - BY-LAWS

The power to adopt, alter amend or repeal By-laws shall be vested in the board of Directors and the shareholders.

ARTICLE XI - RESTRICTIONS ON TRANSFER OF STOCK

Shares of the corporation may be transferred to the corporation, to other stockholders in the corporation or to third persons, but any sale or other transfer to a third person must be approved in advance by the Board of Directors and shall be subject to all terms and conditions or any shareholders agreement in effect at that time.

ARTICLE XII - CUMULATIVE VOTING

At each election of Directors, every shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of Directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principle among any number of such candidates.


ARTICLE XIII - INDEMNIFICATION
