**ARTICLE I**

**Corporate Name and Principal Office**

The name of this corporation is WORKFORCE OF TEXAS, INC. and its principal office and mailing address is 1000 N. Ashley Drive, Suite 600, Tampa, FL 33602.

**ARTICLE II**

**Commencement of Corporate Existence**

The corporation shall come into existence on the date of filing with the Florida Secretary of State.

**General Nature of Business**

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.
