The undersigned subscriber to these Articles of Incorporation ERICHARD'S LAWN TALLAHASSEE, FLORIDA SERVICE, INC., being a natural person competent to contract, hereby acknowledges and files theses ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the provisions of Chapter 607, Florida General Corporation Act and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes does hereby adopt the following Articles of Incorporation.

ARTICLE I

CORPORATE NAME

DURATION
