#### **Article XI - Amendment**

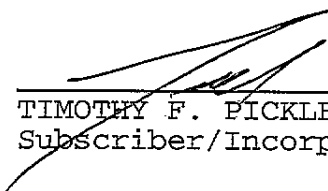

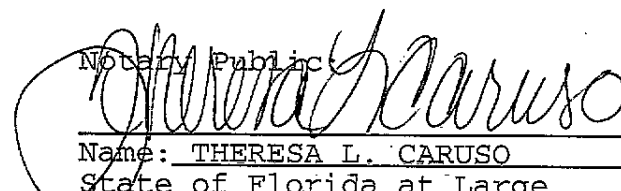

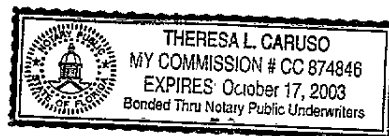
