ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Davie Urgent Care, Inc., and its address is 2581 University Drive, Davie, Florida 33324.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

PURPOSES

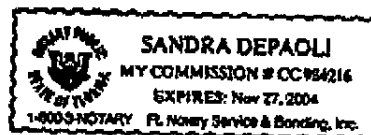
