ARTICLEI

NAME

The name of this Corporation shall be:

MENDEZ S.A., INC.

ARTICLE II

NATURE OF BUSINESS

This Corporation may engage in any activity of business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE III

TERM OF EXISTENCE
