
The date when the corporate existence shall begin shall be the date of subscription and acknowledgment stated herein if this

ARTICLE X - AMENDMENT

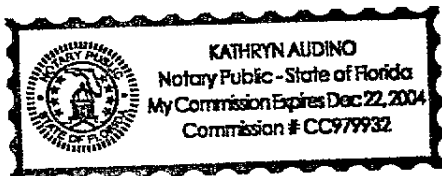




