

#### ARTICLE X - AMENDMENT

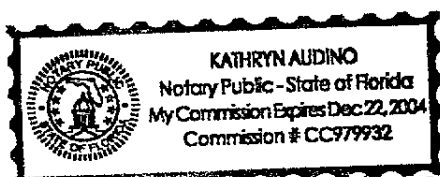


