## ARTICLES OF INCORPORATION OF FLORIDA CONDOMINIUM CENTER, INC.

The undersigned incorporators, for the purpose of forming a corporation and the Florida Business Corporation Act, hereby adopts the following Afficles of Incorporation.

#### ARTICLE I. NAME

The name of the corporation shall be FLORIDA CONDOMINIUM CENTER, INC.

#### ARTICLE II. PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be 1920 East Hallandale Beach Boulevard, Hallandale, Florida 33009.
