THE UNDERSIGNED, who desire to form a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be CREATIVE ENVIRONMENTAL AND CONSTRUCTION SERVICES, INC.

ARTICLE II - PURPOSES

The general purposes for which this corporation is organized are:

- (1) To transact any lawful business or businesses for which corporations may be incorporated under the Florida General Corporation Act.
- (2) To do such other things as are incidental to the foregoing or necessary, implied, helpful, or desirable in order to accomplish the foregoing.

ARTICLE III - DURATION

The term of existence of the Corporation is perpetual.

ARTICLE VI - CAPITAL STOCK

The number of shares of capital stock that the Corporation is authorized to issue is 20,000 shares, all of which shall be voting common shares with par value of \$1.00 per share.

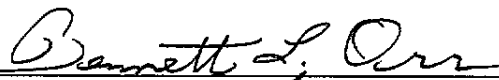

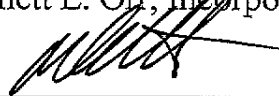
These Articles of Incorporation may be amended in the manner provided by Florida law.

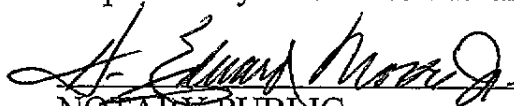
