ARTICLE III. CAPITAL STOCK

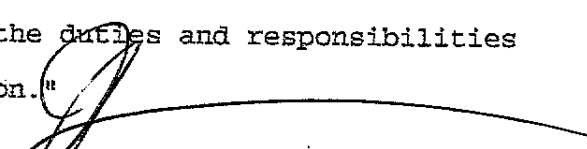
The maximum number of shares of stock that this corporation
