ARTICLE ONE

The name of the corporation is General Data Corporation.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is one hundred thousand (100,000). Shares shall be common, restricted, no par value stock, with unlimited voting rights, together to receive corporate assets on a pro rata basis upon dissolution of the corporation. The corporation is required to approve transfer of restricted shares, and reserves preemptive rights as set forth in F.S. 607.0630.

ARTICLE FIVE

The corporation shall not commence business until it has received for the issuance of shares consideration of the value of one thousand one dollars (\$1001.00) consisting of money, labor done or property actually received.

ARTICLE SIX

The street address of its initial registered office is 3220 Old Burnt Store Road, Cape Coral, Florida 33993, and the name of its initial registered agent at such address is Robert Wm. Smith.

ARTICLE SEVEN

The number of directors constituting the initial board of directors is one, and the name and address of the person who shall serve as director until the first annual meeting of the shareholders or until his successors are elected and qualified is:

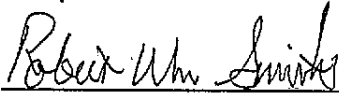
