ARTICLE I – NAME

The name of the Corporation is Purple Haze of Deerfield Beach Inc



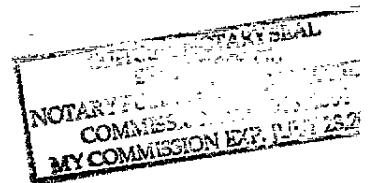


