ARTICLES OF INCORPORATION

OF INDIA 1947 INC.



TO: THE HONORABLE SECRETARY OF THE STATE OF FLORIDA:

The undersigned do hereby make, subscribe, acknowledge and file the following articles for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I.

The name of the corporation shall be:

INDIA 1947 INC.

ARTICLE II.

The general nature of the business to be transacted by the corporation shall be as follows:

To conduct the business of catering and restaurant and other products and all other facets of the business and similar endeavors and to perform all acts as may be necessary to accomplish the foregoing purpose of the corporation.
