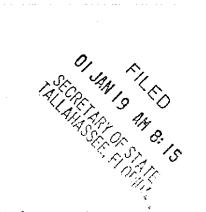

## ARTICLES OF INCORPORATION OF



### UTILITY SITING SERVICES, INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I - CORPORATE NAME

The name of the corporation is Utility Siting Services, Inc.

#### ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida Law.

#### ARTICLE III - PURPOSE

This corporation is organized to deal in goods and services, to deal in real and personal property and for the purpose of transacting any or all lawful business as a corporation incorporated under Florida law.

#### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock.

ARTICLE V-PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation the

same kind, class or series as that which he already holds, shall have the right to purchase

his pro rata share thereof as nearly as may be done without issuance of fractional shares,

at a price at which it is offered to others.

#### ARTICLE XIV - CONTRACTS

No contract or other transaction between the company an any other corporation, whether or not a majority of the capital stock of the same shall be owned by the company, shall be affected or invalidated by reason of the fact that any one or more of the stockholders of the company is or are interested in, or is a director or officer, or are directors or officers of such corporation, and any shareholder or shareholders, individually or jointly may be a party or parties to or may be interested in any contract or transaction of the company or in which the company is interested, and no contract, act or transaction of the company with any person or persons, firm or corporation shall be affected or invalidated by the fact that any shareholder or shareholders, officer or officers of this corporation is a party or are parties to or interested in such contract, act or transaction, or in any way connected with such person or persons, firm or corporation, and each and every person who may become a shareholder of the company is hereby relieved from any liability that might exist otherwise from thus contracting with the company for the benefit of himself or any firm, association, or corporation in which he may in anywise be interested.

#### ARTICLE XV – INDEMNITY OF OFFICERS AND STOCKHOLDERS
