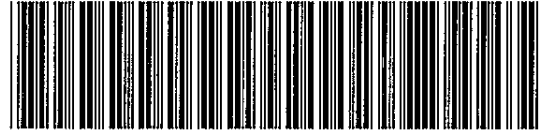


Article I of the Articles of Incorporation of A.F.T. FINISHING SYSTEMS, INC.
