ARTICLE I. CORPORATE NAME

The name of this Corporation is: 512 CD's, Inc.

ARTICLE II. NATURE OF BUSINESS AND POWERS

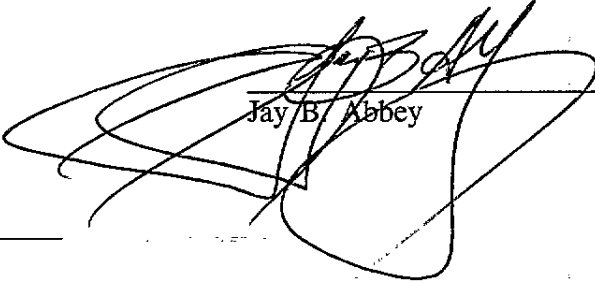
ARTICLE X. AMENDMENT

These Articles of Incorporation shall be effective January 18, 2001, as provided by Florida Statute 607.0123.

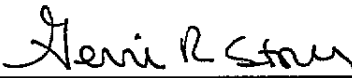

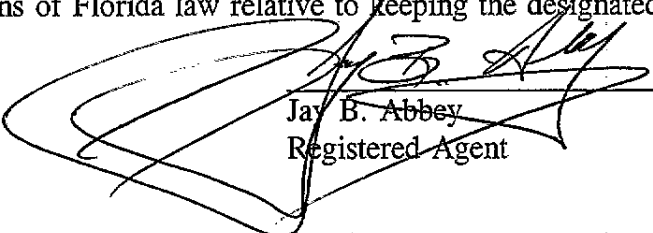
