**ARTICLES OF INCORPORATION  
OF  
AMERISTAFF V, INC.**

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

**I.  
Name**

The name of the Corporation is AmeriStaff V, Inc.

**II.  
Term of Existence**

The date when corporate existence will commence is January 22, 2001 in accordance with the provisions of Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

**III.  
Principal Office**

The principal office and mailing address of the Corporation is 3040 Gulf to Bay Boulevard, Suite 110, Clearwater, Florida 33759.

**IV.  
Capital Stock**

The Corporation is authorized to issue 75,000 shares of \$.10 par value common stock which will be divided into 12,500 shares of Class A Common Stock and 62,500 Shares of Class B. Common Stock. The rights of the Class A and Class B. stock are the same, except that holders of Class A Common Stock will have 1 vote per share and holders of Class B Common Stock will have no voting rights.

Initial Registered Office and Agent**
