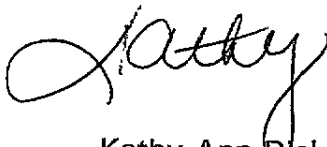

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles Of Amendment to its Articles Of Incorporation:

1. The name of the corporation is presently **THRIFTY OF FLORIDA, INC.**
2. The following Amendment To The Articles Of Incorporation was adopted by the stockholders and directors of the corporation on **February 21, 2001**, in the manner prescribed by the Florida General Corporation Act: The name is changed from **THRIFTY OF FLORIDA, INC.** to **CITRUS SALES, INC.**

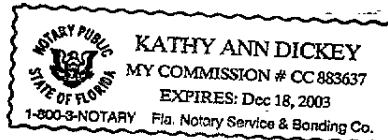
