ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is FIRST RATE MEDICAL CORP..





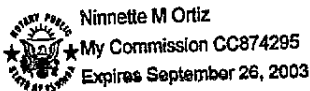
