ARTICLE 1. - NAME

The name of this corporation is INTERNATIONAL PRESENTATIONS
CORP.

ARTICLE 2. - DURATION

This corporation shall exist perpetually unless dissolved
according to Florida law.

ARTICLE 3. - PURPOSE

This corporation is organized for the purpose of transacting
any and all lawful business.

ARTICLE 4. - POWERS

This corporation shall have all of the powers enumerated in
the Florida General Corporation Act.

ARTICLE 5. - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of voting
common stock with a par value of \$1.00 per share.

ARTICLE 6. - PREEMPTIVE RIGHTS

The holders of the common stock of the corporation shall have
the preemptive right to purchase upon such price, terms and
conditions as shall be fixed by the Board of Directors, such of the
shares of the common stock of the corporation as may be issued from
time to time of the corporation which have never previously been
sold or issued. Such preemptive right shall apply to such shares
whether such additional shares constitute a part of the shares
presently or subsequently authorized or constitute shares held in

the treasury of the corporation, and shall be exercised in the respective ratio with the number of shares held by each stockholder at the time of such issue bears to the total number of shares outstanding in the names of all stockholders at such time.



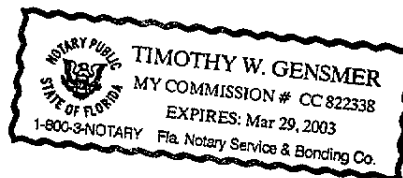


