ARTICLE ONE: NAME

The name of this corporation is Robin E. Raskin-Lanigan, P.A., and the principle business address of the Corporation is 222 East Forsyth Street, Jacksonville, Florida 32202.

This corporation shall have perpetual existence.

The number of directors constituting the initial board of directors of this Corporation shall be 1 and the name and address of said persons who are to serve as member thereof are as follows:



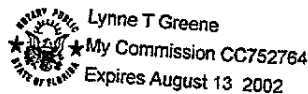
