ARTICLE X- AMENDMENT





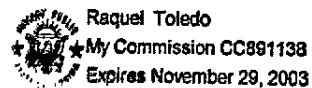
