ARTICLE I - NAME

The name of this corporation is **RECOVERY COFFEE, INC.**, located at 200 West First Street, Sanford, Florida 32771.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing with the filing of these Articles of Incorporation by the Florida Department of State pursuant to the laws of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business which corporations may conduct pursuant to the laws of the State of Florida.


ARTICLE VIII - POWERS
