OFFICERS AND DIRECTORS

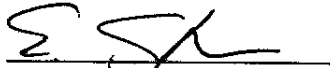

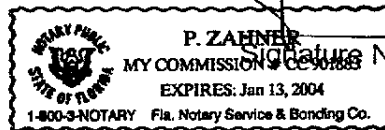
