# ARTICLES OF INCORPORATION OF

### PETER J. ZINAICH, P.A. A PROFESSIONAL CORPORATION



The undersigned, who is duly licensed to practice law in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation:

### ARTICLE ONE NAME

The name of the Corporation shall be Peter J. Zinaich, P.A.

## ARTICLE TWO REGISTERED OFFICE AND AGENT

The location and address of the Corporation's initial registered office in Florida is 1516 East Livingston Street, Orlando, Orange County, Florida 32801. The initial registered agent at the registered office is Peter J. Zinaich.

### ARTICLE THREE PURPOSE
