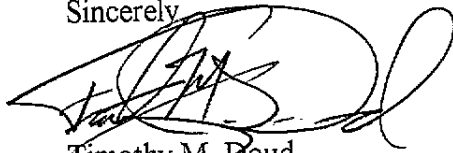

CORPORATE NAME**

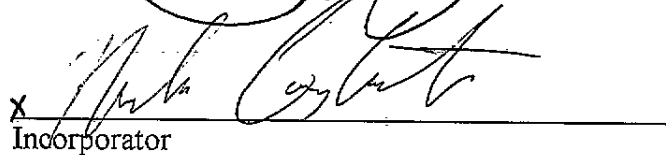
ARTICLE IX AMENDMENT

statement manifesting their intention that a certain amendment of these articles of incorporation be made.

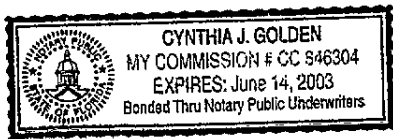
