The name of this corporation is GET MR. PLUMBER PLUMBING SERVICE, INC.



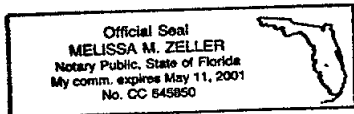


