**Article I - Name**



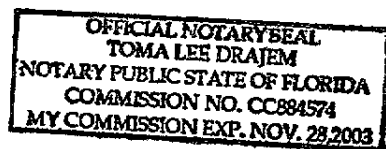


