# ARTICLES OF INCORPORATION

The undersigned incorporator, being a natural person competent to contract for the purpose of forming a corporation under the Florida General Corporation Act, hereby dopts the following Articles of Incorporation in order to form a corporation under the laws of the States of Florida.

# ARTICLE I

The Corporate name is:

# ARTICLE II
