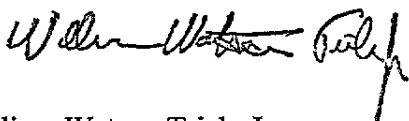

**ARTICLE 1: CORPORATE NAME:** The name of this corporation is Troll Pools Inc.

**ARTICLE 2: PRINCIPAL OFFICE:** The street address of the initial principal office of this corporation is 4747 Nob Hill Road, Sunrise, Florida 33351.

**ARTICLE 3: MAILING ADDRESS:** The initial mailing address of this corporation is 5405 NW 90th Avenue, Sunrise, Florida 33351.

**ARTICLE 4: CORPORATE POWERS:** This corporation shall have the power to engage in all transactions permitted by law, and shall otherwise have all powers and may engage in all business permitted by law.
