## **ARTICLES OF INCORPORATION**

OF

ARTICLE 1: CORPORATE NAME: The name of this corporation is Troll Pools Inc.

**ARTICLE 2: PRINCIPAL OFFICE:** The street address of the initial principal office of this corporation is 4747 Nob Hill Road, Sunrise, Florida 33351.
