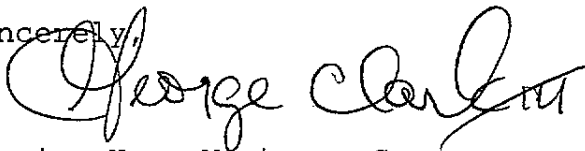

ARTICLE IX - AMENDMENTS

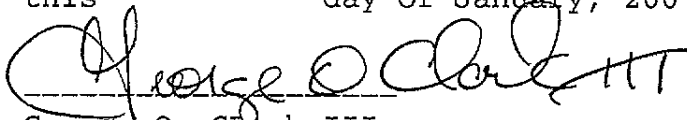

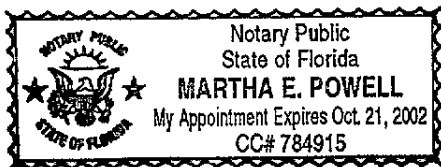

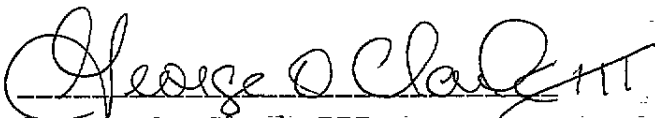
