THE UNDERSIGNED Subscribers to these Articles of Incorporation, as natural persons, competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is: T & R, INC.

ARTICLE II

BEGINNING OF CORPORATE EXISTENCE

The existence of this corporation shall commence on the 24 day of January, 2001; provided that if such day be unauthorized under law, then on the earliest day allowable pursuant to Florida law the corporate existence shall commence.

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of

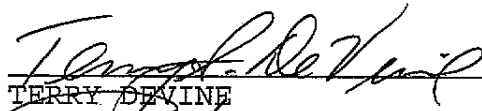
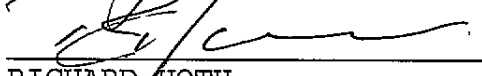

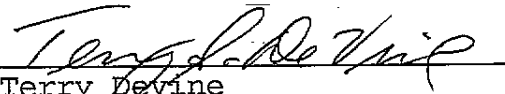
