ARTICLES OF INCORPORATION

OF

The undersigned incorporation, being of full age, does hereby make and file these Articles of Incorporation under the provisions of the Florida General Corporation Act for the purpose of becoming a corporation and does hereby accept all the rights, privileges and obligations conferred and imposed by the laws of the State of Florida,.

ARTICLE I - NAME
