ARTICLE X - AMENDMENT

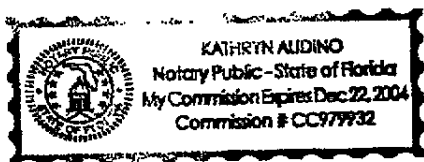
