Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **DIGITAL ARTISTS ACQUISITION CORP.** (the "Corporation"), Charter #P01000009779, filed on January 25, 2001.

2. The following Amendment to the Articles of Incorporation was adopted by the sole Incorporator of the Corporation (shareholder action was not required), on February 1, 2001 in the manner prescribed by Section 607.1005 of the Act:


**ARTICLE I**
