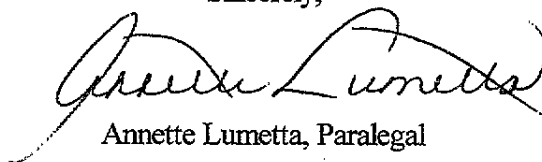

Bylaws

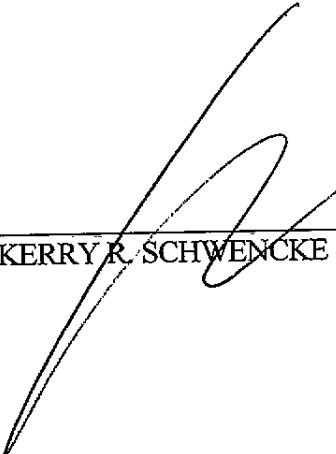

Corporate existence shall begin upon the filing of these Articles of Incorporation.

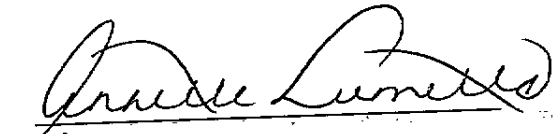

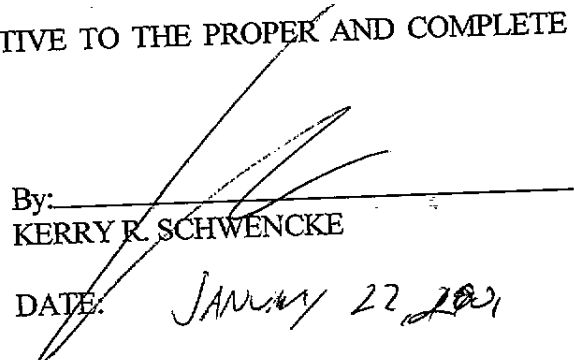
