

ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

Treehouse Development Corporation

ARTICLE II

The principle office of this corporation shall be 1900 Pine Bay Drive, Lake Mary, Florida 32746, but this corporation may establish such other offices and branch offices within or without the State of Florida as may be necessary or as may be determined by the board of directors.
