

# ARTICLES OF INCORPORATION

OF

### THE WFH COMPANY, INC.



THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

### **ARTICLE I, NAME**

THE NAME OF THIS CORPORATION IS THE WFH COMPANY, INC.

# ARTICLE II, PRINCIPAL PLACE OF BUSINESS

THE PRINCIPAL PLACE OF BUSINESS OF THIS CORPORATION WILL BE: 1533 SANTA BARBARA DRIVE, DUNEDIN, FLORIDA 34698

## ARTICLE III, DURATION

THIS CORPORATION SHALL EXIST PERPETUALLY COMMENCING ON THE DATE OF FILING OF THESE ARTICLES.

### **ARTICLE IV, PURPOSE**

THIS CORPORATION IS ORGANIZED FOR THE PURPOSE OF TRANSACTING ANY AND ALL-LAWFUL BUSINESS.

## ARTICLE V, CAPITAL STOCK

THIS CORPORATION IS AUTHORIZED TO ISSUE 500 COMMON SARES OF \$1.00 PAR VALUE.

# ARTICLE VI, PREEMPTIVE RIGHTS GRANTED

EVERY SAHREHOLDER, UPON SALE FOR CASH BY THIS CORPORATION OF ANY NEW CAPITAL STOCK OF THE SAME KIND, CLASS OR SERIES AS THAT WHICH HE OR SHE ALREADY HOLDS, SHALL HAVE THE PREEMPTIVE RIGHT TO PURCHASE HIS OR HER PRO RATE SHARE THERE OF (AS NEARLY AS MAY BE DONE WITHOUT THE ISSUANCE OF FRACTIONAL SARES).

## ARTICLE VII, REGISTERED AGENT AND OFFICE

### ARTICLE X, RESTRICTIONS ON TRANSFER OF STOCK

SHARES HELD OR ACQUIRED BY THE CORPORATION MAY NOT BE RESOLD TO OTHER PERSONS UNLESS FIRST OFFERED TO THE REMAINING SHAREHOLDERS OR TO THIS CORPORATION. THE PRICE AND TEMS ARE WHICH, AND THE TIME WITHIN WHICH THOSE SHARES MAY BE OFFERED AND SOLDE SHALL BE FURTHER SPECIFIED BY WRITTEN AGREEMENT AMONG ALL THE SHARHOLDERS AND THIS CORPORATION.
